NORTHERN COUNTIES ARCHERY SOCIETY

APPLICATION FOR JUDGES UNIFORM GRANT

It was confirmed at the Committee Meeting 22 January 2022 to recommence the existing Judge Uniform Grant Policy for newly qualified county judges, with effect from 1st March 2019.

Existing NCAS qualified judges (as at 16th March 2019) qualified judges who have not yet claimed, will be able to make a claim for re-imbusement for one of the new AGB Judge Uniform shirts.

No further claims against the £150 Grant from previous Policies will be accepted for existing NCAS judges.

Candidate County Judges (current Candidates as of 16th March 2019 and any new starters, whilst this Policy is in place) may claim up to the value of £150 for existing and new uniform items. At the present time, there is no requirement, from AGB, for Candidate County Judges to purchase or wear any uniform before they qualify to County status, in fact NCAS understands they are advised not to buy until they do qualify. ***Should they choose to purchase uniform, whilst still a candidate, they will not be able to claim until they are qualified as a County Judge.***

Claims should be made within 3 months of qualifying as a County Judge.

Only items of clothing ordered from AGB approved suppliers qualify for this grant, and purchase of boots is specifically excluded.

The application for the Judge Uniform Grant must be made on the attached application form and must be accompanied by a receipt for the clothing purchased. The completed application should be sent to the NCAS Treasurer at the address shown below.

Applications via e-mail are acceptable, providing a copy of the clothing receipt is attached.

The Judge is required to purchase the clothing themselves and then claim the NCAS Grant for the amount spent.

The clothing may be purchased in stages and the grant claimed in stages, up to the maximum of £150.

This Version 5 Judge Uniform Grant Funding Policy will be reviewed by the NCAS Committee in January 2023.

Historical Notes

Original Policy May 2015 , set deadline at 31/12/15 with claims before 1/3/16.

Policy revised March 2016, extended deadline to 31/12/16 with claims before 1/3/17.

For newly qualified judges, this policy will be reviewed November 2016.

Policy revised November 2017, extended deadline to 31/12/18 with claims before 01/03/19, for both newly qualified and existing NCAS judges.

Policy revised March 2019 which included the Old supplier Kudos and including shirts for current qualified judges

At the May 2015 Committee Meeting, the NCAS Committee agreed to offer a grant of £150 to existing NCAS judges (as at 09/05/2015) and NCAS Candidate Judges as they qualify to Judge Status (from 09/05/2015), to assist them in the purchase of the new Judges Uniform.

~~This is a "one-off" grant made available to both categories of Judges listed above.~~

~~Revised Policy, November 2016, (extended deadline for purchase and claim);~~

~~For existing Judges, this grant applies only to the new clothing bought before 31/12/2017, with all claims being submitted to the NCAS Treasurer before 1st March 2018.~~

~~For newly qualified judges, this grant funding policy will be reviewed by the NCAS Committee in November 2017.~~

~~Revised Policy, November 2017 (extended deadline for purchase and claim, specifies Kudos purchases only and "boots" not included);~~

~~For existing and newly qualified NCAS Judges, this grant applies to clothing bought before 31/12/18, with all claims being submitted to the NCAS Treasurer before 1st March 2019.~~

~~At the November 2018 Committee Meeting, due to proposed changes to the design and supplier of AGB Judge Uniforms, it was agreed to suspend the existing Judge Uniform Grant Policy, with effect from 31st December 2018, with claims submitted by 1st March 2019.~~
